

## 2026 SOUTH CAROLINA WAHOO SERIES Rules

- 1. Fish days will run from Thursday, February 12, 2026 through Friday, April 10, 2026. No Tournament Entry refunds after February 2, 2026.
- 2. Teams can pick 3 days. Teams can weigh one Wahoo each day. No mutilated Wahoo will be weighed.
- 3. The 2026 South Carolina Wahoo Series champion will be determined by the boat with the heaviest two fish aggregate weight. A single fish can win if it has the most weight overall.
- 4. A captain may only register one boat, however Captains and crews can fish on other boats during the series.
- 5. Teams must declare fish days by emailing marc@scwahooseries.com no later than 9pm the day before you are fishing. Include this required information; tournament boat #, boat name, date of fish day, and what inlet you are fishing out of.
- 6. You may un-declare a fish day, as long as no lines were deployed, by texting Marc (843) 298-0377 with a cell phone only, NOT A SAT PHONE, no later than 7am the morning of the fish day.
- 7. On a declared fish day teams can not leave the dock or ramp prior to 12 midnight. Tournament fishing hours, lines in no earlier than 7:00 am. Lines out no later that 5:00 pm.
- 8. Boats must be checked in on their declared fish day no later than 8:00pm with a cell phone only, NOT A SAT PHONE, by texting 843-298-0377. Check-in must include required pictures. Check-in is mandatory to qualify for next day weigh-in.
- 9. During the Series all fish must be weighed in at Hilton Head Harbour Marina, Hilton Head Island, SC, Tolers Cove Marina, Mt. Pleasant, SC, Georgetown Landing Marina, Georgetown, SC or Crazy Sister Marina, Murrells Inlet, SC no later than 11:00am the day after you fish. Any team that wants to weigh in on the same day, must be in front of the fuel dock at Tolers Cove Marina, Hilton Head Harbor Marina, Georgetown Landing Marina or Crazy Sister Marina no later than 5pm! Teams fishing the Last Day, Friday, April 10, 2026 have to weigh in the same day, and must be at the official scale location by 5pm.
- 10. Any tie will be broken by the boat with the heaviest Wahoo.
- 11. Boundaries: Teams cannot travel, catch bait, deploy teasers or fishing lines of any kind outside of the Tournament boundaries during a declared fish day. All Teams must leave from within the inlet boundaries of Little River Inlet to St Simons Inlet, and fish within these boundary lines. North Boundary, Little River, SC draw a straight line through the following GPS coordinates; Mark one, 33:50:00 and 78:25:00 to Mark two 33:15:00 and 77:30:00. The south Boundary is 30:50:00.
- 12. Fish must be caught by rod and reel. No spear guns or harpoons allowed. No electric reels are permitted for trolling any hooked bait or lure. Electric reels can be used for hookless teasers.
- 13. A picture of your Teams fish must be taken after the catch, before it is iced down, with the Tournament Boat # in it, as well as Team members, including SR, Lady and Jr Anglers. Include these pictures a part of your check in text. Pictures of fish in the box are not acceptable.
- 14. A picture of the teams GPS screen must be taken prior to leaving the inlet, and submitted upon check-in. Your GPS screen must include the following information: time, date and ships' position coordinates.
- 15. You may substitute a boat one time if there is a mechanical issue, boat sale or unforseen circumstance. The substitute boat must not be registered in the tournament. If the substitution is due to mechanical, boat sale or unforseen circumstances, and the boat will not be ready for the remainder of the series, you must complete the series in the substitute boat, you can not switch boats again. Chartering a boat is not allowed.

- 16. Boats are not allowed to come together for any reason during tournament fishing hours.
- 17. All registered boats and participants must comply with SC State and Federal regulations including but not limited to fishing license, permits, boat registrations and safety equipment.
- 18. It is the vessel owners' responsibility to have in place or obtain adequate Liability insurance to cover each and every crew member, participant and guest, as well as others if an incident occurs involving others not on the vessel.
- 19. No culling of dead fish allowed in the SC Wahoo Series.
- 20. Teams are subject to random boat inspections, prior to departure, or upon return from a series fish day.
- 21. Teams are required to save their GPS track from their declared fish day until 1pm the day after their declared fish day.
- 22. Teams are not permitted to freeze or brine your fish frozen. Teams are not permitted to alter or attempt to alter the weight prior to weigh-in.
- 23. A formal protest, or other circumstances may result in the need to administer Polygraph Test(s). All tournament participants are subject to Polygraph Test(s). By registering for the 2026 SC Wahoo Series participants agree that the results of Polygraph exams are final, and that they will abide by the results.
- 24. Any protest filed must be submitted to the SC Wahoo Series in writing accompanied by a \$700 cash only non-refundable fee and delivered 30 minutes after the scale closes (12:30pm) for that fish day you are protesting. And, on the final fish day April 10, 2026 any protests must be submitted by 5:30pm.
- 25. The Rules Committee has the sole right to interpret the rules, and address issues not covered in the rules. All decisions made by the committee are final.
- 26. The tournament Director has the right to refuse any entry.
- 27. This is a Captains Choice Tournament. Each Captain is solely responsible for the safety of his or her vessel, crew, and guest at all times during the SC Wahoo Series. Captains are responsible for heeding any weather warnings and severe weather warnings that may affect his or her three SC Wahoo Series fish days as Safety is paramount. It is up to each Captain to decide whether his or her vessel is seaworthy for the sea conditions of all three SC Wahoo Series fishing days. Captains are responsible for supplying a flight plan for all three of his or her SC Wahoo Series fish days with a family member, or trusted individual.
- 28. A small craft advisory: if a small craft advisory is in affect from 5am on, for a fish day, that fish day is canceled. However, we have several inlets within our tournament boundary, and therefore several NOAH marine forecast zones. The cancelation of a fish day will be limitted to the zone or zones that have a small craft advisory in affect at 5am. If on that same day, other NOAH marine forcast zones within the torunament boundary do not have a small craft advisory in effect teams may fish out of those zones.
- 29. A team/boat violating any of these Tournament Rules, or any team/boat containing a participant violating any of these Tournament Rules is subject to disqualification from the Tournament.
